### INTRODUCTION

An exciting opportunity has arisen for the role of Procurement Specialist sitting within the university's Procurement Team within Finance & Procurement Directorate.

The post-holder will join a forward-thinking and supportive procurement team. As part of the wider Finance Directorate, we aim to deliver excellent procurement services to the University's academic, teaching and research staff and our professional services colleagues.

## JOB DESCRIPTION

### MAIN PURPOSE OF THE ROLE:

This new role is to support the Head of Procurement & the Contracts Manager to manage and deliver an end-to-end professional procurement service across the University and more specifically within Estates & Facilities (E&F). To identify areas to add commercial benefits in whole life costing, as well as providing compliance with University Procurement policy, public procurement legislation & the World Trade Organisation - Government Procurement Agreement (GPA) and improve value and quality while minimising risk. Apply best practice supplier relationship and contract management techniques.

### **KEY RESPONSIBILITIES:**

- To engage with key stakeholders in Schools and Directorates (more specifically within Estates & Facilities due to the typically high value & complex projects), to agree procurement priorities and deliver on the support and processes required to achieve these on time and within budget. This will include time-bound works programmes/projects, one-off equipment, goods and services acquisitions.
- To work closely within the Procurement Team to deliver a high-class procurement service and ensure that procurement processes are streamlined and facilitate compliance with University procurement policies & procedures and Public Contracts Regulations
- To support procurement of complex and high value works, goods & services by providing professional sourcing advice and market intelligence, and execution of contract that maximise value for money, sustainability and ethical sourcing, and ensure supply chain resilience.
- Identify most appropriate Form of Contract and create & prepare contractual documents, with effective implementation of new agreements across the University, supporting stakeholders with appropriate training as required.
- To manage supplier performance against appropriate Key Performance Indicators, continually seeking service improvements and best value for money. Managing key supplier/client relationships.



Salary will be at the appropriate point on the Grade 6, £34,304- £40,927 per annum and negotiable with placement according to qualifications and experience.





# THE DIRECTORATE OF FINANCE & PROCUREMENT

The Directorate's responsibilities include the regulation of all income and expenditure of the University, and for ensuring that the systems of accounting and internal control are adequate and in accordance with laid down standards. The section also deals with insurance and investments and is responsible for Procurement services.





### ABERDEEN AND ABERDEENSHIRE

Scotland's third largest city, Aberdeen sits on the coast between the mountains of Aberdeenshire and the stunning North Sea coastline. The Aberdeen City region is a can-do place that is actively investing, at scale, in its future.

Renowned as a Global Energy Hub, Aberdeen is a vibrant, entrepreneurial region, home to a unique mix of business opportunities and specialist skills across various sectors including energy, technology, life sciences and food & drink. More than 20% of Scotland's top businesses are located in this region which is taking great strides to ensure that it continues to compete on a world stage. Investments of more than £10 billion of public and private infrastructure is due to be delivered before 2030, marking an exciting time to be part of a genuine world-class location.

Built from sparkling local granite Aberdeen has earned the name of the Silver City. Flying time to London is just over one hour with regular daily flights and serves international travel to European centres such as Amsterdam (Schiphol) and Paris (Charles de-Gaulle) as well as flights to other European destinations.

The City and the surrounding countryside provide a variety of urban, seaside and country attractions. Aberdeen has first class amenities including <u>His Majesty's Theatre</u>, <u>Music Hall</u>, <u>Art Gallery</u>, <u>the P&J Arena</u>, <u>Museums</u>, and <u>Beach Leisure Centre</u>. The City is framed by its accessible beach front which is within a short walk of the city centre and there are an array of activities available across the region such as hill walking; mountaineering; sailing; surfing; salmon, trout and sea fishing; golf; sailing; surfing and windsurfing. The surrounding countryside, known as Aberdeenshire, is also one of Scotland's most appealing regions. Royal Deeside and the Cairngorms National Park are within easy access of the city, and there are a variety of towns and villages scattered along the coastline.

The city and the surrounding area have ranked consistently highly in nationally recognised quality of life surveys, coming out top 10 as one of the best places to live in Scotland in 2020 in the annual Bank of Scotland survey.
